ARTICLES OF INCORPORATION

The undersigned, for the purposes of forming a corporation not for profit under Chapter 617, Florida Statutes, do hereby adopt the following Articles of Incorporation.

ARTICLE 1. NAME. The name of this nonprofit corporation is LAKE COUNTY DUPLICATE BRIDGE CLUBS, INC.

ARTICLE 2. DURATION. The duration of the corporation is perpetual.

ARTICLE 3. PURPOSE. The purpose or purposes for which this nonprofit corporation is organized are the following:

(a) To lease, purchase, own, hold and otherwise acquire its real property, at a cost not in excess of \$100,000.00.

(b) To provide for the operation of or operate Bridge Clubs for the education and advancement of the skills of its members, their guests, or the public in bridge card playing, especially duplicate bridge.

(c) To sponsor and conduct tournaments under the authority of the American Contract Bridge League, or its successor and the promotion of the number and quality of such tournaments.

(d) To provide for the social and recreational activities of its members.

(e) To promote, sponsor and support in whole or in part worthy civic and charitable causes.

(f) To do such other things as are incidental to the purposes of this nonprofit corporation or necessary or desirable in order to accomplish them under the powers enumerated under Chapters 607 and 617, Florida Statutes.

(g) The private property of the members of this nonprofit corporation shall not be liable for its corporate debts.

ARTICLE 4. Members. The membership of this nonprofit corporation shall be composed of any person a citizen of the United States of America irrespective of race, color, religion or national origin approved by the Directors. The Bylaws shall establish the class or classes of membership and provide for Certificates of Membership, fees and dues.

ARTICLE 5. INITIAL REGISTERED OFFICE AND RESIDENT AGENT.  
The initial registered office is 1512 Orange Avenue, Tavares, Florida 32778 and the initial registered agent is CHRISTINE R. DINSMORE of 1512 Orange Avenue, Tavares, Florida 32778. The registered office and agent shall hereafter be designated and appointed by the Board of Directors and both office and agent shall be in the State of Florida.

ARTICLE 6. INITIAL BOARD OF DIRECTORS. The number of Directors constituting the initial Board of Directors is five. The number of Directors may be increased or decreased from time to time in accordance with the Bylaws, but shall never be less than three.
